1. <u>Situation</u>. To establish policies and outline the method of implementation of the II Marine Expeditionary Force (MEF) Sailor 360 Development Program.

2. <u>Mission</u>. To provide guidance for the establishment of a Sailor 360 program which was developed to succeed the Chief Petty Officer (CPO) 365 training development guide in accordance with the Master Chief Petty Officer of the Navy's (MCPON) Laying the Keel guidance. This program is to serve as a Sailor's development guide over the continuum of their career.

### 3. Execution

## a. Commander's Intent and Concept of Operations

- (1) <u>Commander's Intent</u>. Sailor 360 functions as a Command directed program. Participation is highly encouraged; progress and participation may be considered when ranking Sailors for periodic evaluations, Sailor of the Quarter/Year, Meritorious Promotion, and other recognition programs.
- (2) <u>Concept of Operations</u>. Ensure all Sailors have the opportunity to grow in their personal and professional leadership and development.

## b. Subordinate Element Missions

# (1) II MEF CE Program Manager shall:

- (a) Conduct a semi-annual review of the Sailor 360 Development Guides to ensure all references and content are updated with current instructions and policies.
- (b) Train all Major Subordinate Command (MSC) Program Managers on how to document the completion of the Sailor 360 Development Guides.
- (c) UIC 55207 Program Manager will plan two events per month dependent upon the operational tempo.
- (d) Responsible for ensuring that every Sailor receives a copy of their respective Sailor 360 Development Guide upon checking in to Command Element II MEF and its direct subordinate elements.

## 4. Administration and Logistics

### a. Administration

- (1) Each Major Subordinate Command Program Manager will ensure the development and administration of a Sailor 360 program that is aligned to reference.
- (2) Each MSC will also ensure the designation of a Program Manager to administer their respective program and be a liaison to the CE II MEF Program manager. MSC Program Managers will at a minimum have a Sailor 360 program that meets on a monthly basis.
- (3) Records created as a result of this instruction, regardless of media and format, shall be managed in accordance with SECNAV M-5210.1 series.
- (4) All required forms are available from the II MEF Sailor 360 Program Manager.
- b. <u>Logistics</u>. II MEF Command Master Chief (CMDCM) is responsible for this instruction and will assign a Chief Petty Officer (CPO) to serve as the program manager. The CMDCM is also responsible for requesting funds to procure the Sailor 360 Development Guide books.

## 5. Command and Signal
