## Policy Letter 10-18

Subj: MILITARY MANPOWER REQUIREMENTS AND STAFFING FOR THE II MARINE

EXPEDITIONARY FORCE G-10 DIVISION

1. The current II Marine Expeditionary Force (II MEF) table of organization (T/O) shows 13 Active Reserve (AR) billets in the G-10 and Reserve Integration Division (RID). The current breakdown is as follows:

2. II MEF will use an AR structure review in 2018 to re-align AR structure to reflect actual requirements. The proposed breakdown is as follows:

- 3. II MEF will pursue a change to the T/O to reflect the Commanding General's requirement for three active component Marines in the G-10: 1-LtCol/8006, 1-GySgt/8014, and 1-Sgt/8014.
- 4. Pending approval of a T/O change request, the II MEF Commanding General has directed the II MEF G-10 will be staffed with 1-field grade officer, 1-SNCO, and 1-NCO.
- a. Today, the II MEF G-10 is staffed with 1-major, 2-GySgts, 1-SSgt, and 1-Sgt. All of the Marines are from the AR component. One of the GySgts and the SSgt are due to transfer from the G-10 in the next few months. Their replacements will be assigned to new sections according to the proposed re-alignment.

The AR major billet in the II MEF G-4, AR gunnery sergeant billet in the II MSB S-3, and one AR sergeant billet in the II MEF G-1 will be internally mapped (i.e., assigned) to the II MEF G-10 until such time that the aforementioned permanent active component manpower solution is in place for the G-10. The current BICs are M2013300907, M2013300909, and M2013300917, respectively.
- c. Until permanent active component structure is available, the field grade officer assignment will alternate between active component and AR Marines approximately every 18 months, or as directed by the Chief of Staff.
