- 1. <u>Purpose</u>. Communications support request timelines must be adhered to in order to (IOT) provide sufficient time for processing at II Marine Expeditionary Force (MEF) G-6 and subsequently meet higher headquarters deadlines. Timely submission and adherence to deadlines ensures that requests can be properly staffed and supported for exercise/operational requirements.
- 2.  $\underline{\text{Information}}$ . To establish guidance and guidelines to subordinate units on the lead time required for the variety of services that may be requested from the II MEF G-6. All requesting units will strictly adhere to this guidance IOT receive the services within the requested timeline.

# 3. Scope

### a. Commanders Intent

- (1) <u>Purpose</u>. To ensure timely communications support for requesting units in support of exercise and operational requirements.
- (2) <u>Method</u>. Major Subordinate Commands (MSCs) and Major Subordinate Elements (MSEs) will forward their communications support requests and/or their subordinate unit's communications support requests to the II MEF Assistant Chief of Staff (AC/S) G-6 for processing and routing to adjacent or higher headquarters as required. As required, network architecture diagrams will be submitted with requests as required to facilitate the processing of requests.

(3) End State. Subordinate units leverage communications capabilities to provide optimal support to MSCs and MSEs exercise/operational requirements.

## b. Tasks

### (1) AC/S G-6, II MEF

- (a) Enforce MARFORCOM, HQMC, CCMD, DISA, and Department of Defense (DoD) policies to facilitate comprehensive and timely submissions of communications support requests for MSC/MSE's exercise and operational requirements.
- (b) Validate subordinate unit requests for communications support; endorse and forward communications support requests to higher headquarters on behalf of II MEF CE and subordinate units.
- (2) Commanding Generals, 2d Marine Division, 2d Marine Aircraft Wing, 2d Marine Logistics Group.
- (a) Enforce the timeline enclosure (1) to facilitate comprehensive and timely submissions of communications support requests and network diagrams for all exercise/operations requirements.
- (b) Validate, endorse, and forward subordinate unit requests for communications support to higher headquarters.
- (3) Commanding Officers, II Marine Information Group, 22nd, 24th, and 26th Marine Expeditionary Units (MEUs).
- (a) Enforce the timeline enclosure (1) to facilitate comprehensive and timely submissions of communications support requests and network diagrams for all exercise/operations requirements.
- (b) Validate, endorse, and forward subordinate unit requests for communications support to higher headquarters.

## c. <u>Coordinating Instructions</u>

- (1) Reference G establishes II Marine Expeditionary Force's policy for Satellite Access Requests (SAR) and Department of Defense Gateway Access Requests (GAR). It articulates the categories and priorities of Satellite Communications (SATCOM) services and identifies operational processes and management responsibilities.
- (2) Requesting units that deviate from the timelines listed in enclosure (1) will submit an Exception to Policy (ETP) letter explaining the reason for the late request. The ETP will be endorsed by the MSC/MSE's AC/S G-6 and routed to the II MEF G6 Operations Officer/Chief for approval. The II MEF AC/S G-6 will make every reasonable effort to support communications requirements for MSC's and MSE's; late submissions, however, will not guarantee support with the requested timeframe and may be subject to disapproval.
- (3) For all ATO submissions, requesting units must include (10) additional workdays for processing required by II MEF G-6 Department Of Defense Information Network (DODIN) Operations section IOT allow ample time for submission to the Marine Corps Cyberspace Operations Group (MCCOG)/HQMC C4 Assessment and Authorization. In accordance with ECSM-18(reference h), this letter must be signed by the first General Officer in the chain of command requesting priority handling, specifically addressing the reason for the deviation from standard processing timelines. Reference H illustrates the

timelines associated with ATO submissions. It further addresses procedures and processes required for approval of late submissions.

- (3) High priority missions in support of real world operations/contingencies will be processed as quickly as possible and are not necessarily required to adhere to the established timelines.
- (4) <u>Submission of Communications Support Requests</u>. Requesters will be familiar with the references and detailed instructions for submitting communications support requests which are located on the II MEF G-6 SharePoint site at: https://eis.usmc.mil/sites/IIMEF/G6/SitePages/SPE.aspx
